Terms of Service and End User License Agreement (EULA)

*NOTICE TO USER: Thank you for your interest in Monflo product. This Terms of Service and End User License Agreement (EULA) describes the terms and conditions under which you may install, use and distribute Monflo Software. Do not install or use Monflo Software until you have read and accepted terms and conditions of this End User License Agreement. By Installation or use of Monflo Software you will be deemed to accept the license terms.*

## **1. DEFINITIONS**

- 1.1 Software – Monflo software (Monflo applications for Android, Windows or any other operating system)
- 1.2 Monflo Server - Monflo Server application for PC
- 1.3 You/User – the end user of the Software.
- 1.4 Agreement – this Terms of Service and End User License Agreement (EULA)
- 1.5 Mirillis – Mirillis Sp. z o.o.
- 1.6 Services - all services made available by Mirillis, including, but not limited to, services accessed through the Software, with web browser or by any other online communication means.
- 1.7 Monflo Services - Software and Services
- 1.8 Free Version - Software version available for free, providing limited functionality
- 1.9 Party – Mirillis Sp. z o.o., licensed end user.
- 1.10 Third Party – any other company or user different from Parties in point 1.9.

## **2. LICENSE, SOFTWARE USE AND DISTRIBUTION**

### **2.1 LICENSE**

Mirillis Sp. z o.o. grants you the non-exclusive, non-transferable, limited right and license to install and use the Software as long as you comply with the terms and conditions of this Agreement. The Software is licensed to you and you hereby acknowledge that no title or ownership of the Software is being transferred or assigned and this Agreement is not a sale of any rights to the Software. Any future Software versions or updates may include updated Agreement. Please read it carefully before installing Software updates.

### **2.2 SOFTWARE USE**

You may install the Software on unlimited number of devices. The number of devices that can use the Software and Monflo Services at one time is limited by your license or subscription version.

#### **2.2.1 General Software information and requirements**

##### **2.2.1.1 Monflo Account**

To use all Monflo Services it is required to create a Monflo Account. To create Monflo Account You must complete and submit an online registration form providing your e-mail address/username and password. To keep the Monflo Services secure, you should keep all usernames and passwords confidential.

##### **2.2.1.3 Free Version**

The Free Version of the Software may be used only for personal, non-public, non-commercial use. Software functionality is limited by your license or subscription version. For suitable Software functionality it is required to purchase appropriate Software license.

#### 2.2.1.4 Commercial use

For commercial use of the Software it is required to purchase Commercial use Software license. You may not use Free Version nor Home use license version for public nor commercial purposes.

#### 2.2.1.5 Network connection

The Software requires a network connection. The Software may use mobile data connection. Mobile data use may incur additional charges from your operator.

#### 2.2.1.6 Connect Anywhere

It is required to purchase additional subscription for unlimited access to Connect Anywhere function.

Video streaming using Connect Anywhere is limited to maximum 1080p and 30fps.

#### 2.2.1.7 High-risk use

You acknowledge that the Monflo Services are not intended for use and/or access in or during high-risk activities including (but not limited) to: life support systems, traffic control (including air traffic), medical activities and any other activities or systems where any malfunction can result in death, personal injuries or damage to physical or intellectual properties. You agree to hold Mirillis and its officers, directors, employees, agents, affiliates and licensors harmless from any claims or losses resulting from any of the foregoing uses of the Monflo Services.

### 2.3 TRANSFER

You may not sell, rent, lease or sublicense the Software to another party.

Only Mirillis Partners are authorized to resell Software licenses or subscriptions.

You may not sell, rent, lease or sublicense the Software to another Party. The Software may not be bundled or distributed with any other package without permission of the copyright holder. All video recordings, audio recordings and screenshots recorded with the Software may be freely used and distributed as long as you make sure to compliance with applicable local laws (including, but not limited to, your local Copyright Law).

### 2.5 TERMINATION

These Agreement will continue to apply until terminated, either by User or Mirillis as set forth

below. You may terminate these Agreement at any time by permanently deleting the Software from your mobile or any other device in its entirety.

Your license rights to the Software under this Agreement will terminate automatically without any notice from Mirillis if you fail to comply with any term(s) or condition(s) of this Agreement. In such event, you must immediately delete the Software and cease to use the Software.

Mirillis may, at our option and in addition to other remedies, immediately and without notice terminate these Agreement at any time or suspend access to the Monflo Services: (i) if Mirillis is required to do so by law; (ii) if Mirillis decides, at its sole discretion, to discontinue offering the Monflo Services; or (iii) for any other reason. Mirillis shall notify You in advance about Agreement termination. Mirillis shall not be liable for any loss or damages resulting from a termination of these Agreement.

## 2.6 CONSENT TO USE DATA, INTERNET CONNECTION AND THIRD PARTY SOFTWARE

You agree that Mirillis may collect technical information about your Software and computer to provide information about Software updates availability. You agree that the Software may use third party software and internet connection to provide full Software functionality, including but not limited to: third party software audio and video recording, checking Software updates availability, validate Software license or subscription.

## 2.7 OWNERSHIP

You acknowledge that the Software contains proprietary and confidential information that is protected by applicable intellectual property and other laws, and Mirillis and/or third parties own all right, title and interest in and to the Software and content, excluding content provided by you, that may be presented or accessed through the Software, including without limitation all Intellectual Property Rights therein and thereto. "Intellectual Property Rights" means any and all rights existing from time to time under patent law, copyright law, trade secret law, trademark law, unfair competition law, and any and all other proprietary rights, and any and all applications, renewals, extensions and restorations thereof, now or hereafter in force and effect worldwide. All rights not expressly granted here are reserved by Mirillis.

result in immediate and automatic termination of this License and may result in criminal and/or civil prosecution.

You acknowledge and agree that the entire risk arising out of use or performance of the Software remains with the user. You acknowledge and agree that when you use this Software in other locations than Poland then you do so on your own initiative and responsibility, and make sure to compliance with applicable local laws.
